- **4.** Steal something: to take something without permission.


In other words, O'Banion's days may be numbered if Jones has anything to do with it.

- 1. November 14th, 2002, for \$5,000.00.
- 2. January 14th, 2003, for \$10,000.00.
- 3. August 4th, 2003, for \$3,538.00.

Merced County records indicate that the loans of \$5,000.00 and \$3,538.00

have been paid, but the loan of \$10,000.00 is still owed.



In Silence is Golden a letter to Jones was reprinted from February 2007 that requested information about loans from Hostetler (see excerpt below):

Letter to Jones 02/26/07

"For the record, I respectfully request for you, Mayor Jones, to disclose if you ever received any financial loans, contributions, or support from Mr. Greg Hostetler.

Or, if your attorney ever received any funds from Mr. Hostetler, at the time you were pursuing a lawsuit against the City of Los Banos, thereafter, or before?"

There was no response to the letter.

The Los Banos City Council Meeting Notes of March 5th, 2003 listed in the Closed Session Agenda states:

"EXISTING LITIGATION - TOMMY JONES."

It does seem with very little doubt, that Mayor Jones was receiving financial support from Hostetler during his litigation against the City for Police officers allegedly planting crack cocaine in Jones' car. No wonder Jones didn't respond to the letter of February 26th, 2007.

When civil servants have been caught doing something wrong, they clam up, or also in Mayor Jones' case, accuses the accuser of being a dangerous member of the Ku Klux Klan.

conflict of interest, a whole other can of worms is opened.

Many matters will need to be reviewed and re-considered.

A letter from The Badger dated March 7th, 2008 to City Attorney William Vaughn was responded to by Vaughn assuring that various documents are forthcoming However, Vaughn did not answer my questions. See page 19-20. I responded with the letter on page 21-22.

A DARK CLOUD

Sources that spoke on the condition of anonymity have disclosed to The Badger that Councilman Tom



Faria had presented copies of the trust deeds to City Attorney William Vaughn for comment.

If such was in fact done, then it seems that Vaughn should have presented such information to the other council members.



In my opinion, ANY and All city council members that knew about the loans and didn't say anything about them should be placed under the same dark cloud as Jones.

Buck Weaver of the 1919 White Sox was banned from baseball for life, even though it was found he did not participate in fixing the World Series. Weaver was banned for not reporting his knowledge of it to officials.


I submit that our civil servants should be held at least to the same standard of accountability to the public as a baseball player. If Vaughn says he did not feel it was important to inform city council members of the Hostetler loans, then, even though I consider Vaughn an old friend, I would have to earnestly say I think he made a very bad call.

THE BELL CANNOT BE UN-RUNG



The bell cannot be un-rung regarding Jones' undisclosed loan from Hostetler.

Jones, as Mayor of Los Banos, has publicly and staunchly supported the annexation of farm land for the benefit of Hostetler. Even if Jones now disqualifies himself from voting upon the annexation issue, the damage is already done.

There is no way to measure how much, or how little, his beating the

annexation drum for Hostetler whom he borrowed money from has effected public opinion.

The annexation train must be brought to a screeching halt along with any other matters that Mayor Jones has thrown his two cents in upon.

It makes no difference if they relate to Hostetler or not. What matters is the connection of Mayor Jones to them, and what he may not have disclosed, that citizens should have known about.

The old, "Fool me once, Shame on you, Fool me twice, Shame on me" should be the guiding operative from this time forward with Mayor Jones and, unfortunately, our city council.

INVESTIGATION REQUIRED

All City council members and City Manager Rath need to be put on the spot to



answer if they knew about the Hostetler loans to Jones but said nothing.



Regrettably, just as the fate that befell Buck Weaver shows, the good ones sometimes get thrown out with the bad.


Mayor Jones' cavalier attitude has cast an onus on all the city council, those close to it, and him.

No doubt a thorough investigation of Mayor Jones' financial dealings with Hostetler is required. Stringent civilian oversight is a must based upon the fact that civil servants cannot be trusted to seriously investigate each others' malfeasance.

The investigative process exhibited by Supervisor Jerry O'Banion, Merced County Counsel James Fincher, and Risk Management Director Brad Smith outlined briefly in *We Found Ourselves*

O'Banion, Fincher, and Smith were in control of letting the public claim against themselves die on the vine without an investigation.

FAIR POLITICAL PRACTICES COMMISSION

Mayor Jones is required by law to report loans from individuals by the Fair **Political Practices** Commission (FPPC) on Form 700/Statement of **Economic Interests and** signed under penalty of perjury.



On March 13th, 2008, I discussed with an enforcement specialist at the FPPC the information I had obtained from the Merced County Recorders Office and the LB City Clerk's Office.

The enforcement specialist said any unpaid loans such as the \$10,000.00 one from Hostetler to Jones was required to be listed on the Form 700. It was not.

Therefore, I have filed an FPPC Complaint against Mayor Jones (See page 12-13) and will keep readers posted as to the outcome.

CIVIL SERVANTS & HOSTETLER

Mayor Jones is in an entirely different position than Hostetler concerning accountability to the public over the undisclosed loans.



Hostetler has no accountability to the

public in the matter. If he so wishes to loan money to Jones, it is entirely his business to do so.

In the February 2007 issue, A Day at the Races, I explained my way of thinking about the matter. For convenience's sake, the segment can be read on page 11.



I do not fault Hostetler for making the loans to Jones, even though I do not personally condone or support it. I fault Jones, a civil servant, for taking the loans.

Business people have been conditioned by uncivil civil servants to pay their dues to survive.

If Hostetler did not pay, I assure you, there is a standing line of his competitors that would.

A gent like Tommy Jones will smile and babble about what a good Christian he is (as stated in LBE article "\$1 Million claim filed against Mayor, city" 5/18/07) while stuffing his pockets with money and favors.



Dear Mr. Vaughn:

Thank you for your timely response to my letter of March 7th, 2008, and your response to my letter of February 13th, 2008, albeit it was untimely. I had to toss that in to keep the record straight, my friend. I will also add that about 95% of your letter was a re-listing of what I asked while not providing a response to my main question due your assertion of the attorney client privilege.

Perhaps this took place from either you not understanding my question, or an overabundance of caution on your part to protect the privilege that led to its misapplication. Even though not an attorney, I consider myself pretty knowledgeable on the subject, and I do think you will agree with my position once explained.

Basically, you refused to confirm to me if Councilman Tom Faria provided you as the City Attorney copies of the subject trust deeds evidencing loans from Mr. Greg Hostetler to Mayor Tommy Jones by asserting such privilege. The attorney client privilege only applies to certain conversations and written communications between a client and his attorney.

The questions I asked you basically were:

- Did Councilman Faria give you copies of the subject trust deeds?
- 2. Did you give copies of the trust deeds to other city council members and when?
- 3. If you already had copies of the trust deeds and you did not present them to council members, please explain why you did not?

I did not ask you to divulge any conversations between you and Councilman Faria. The trust deeds are public records and are not confidential privileged writings by Councilman Faria to you. Therefore, no attorney client privilege applies in either situation. I will also say that it would be interesting to have clarified as to if you as City Attorney serve the citizens first, and they are your real clients in interest, rather than your serving the city council members who are civil servants of the citizens. Either way, it seems asserting an attorney client privilege between yourself and council members about matters of citizens that are not confidential may not be well taken, or even available to you.

Your informing me upon my request if you presented copies of public records to city council members also would not fall under the protection of the attorney client privilege.

Therefore, I respectfully ask again that you provide answers to questions #1-3. If you disagree with my position, I ask kindly that you explain why in detail and cite the appropriate cases to support your position.

I also add that I have no knowledge of any attorney client privilege existing for a City Attorney that would override obligations to protect citizens from possible malfeasance by city officials. I submit that the

The letter to Chevron requested that it take full financial responsibility for the

I have spoken to Mr. Santos, and he said he would be more than happy to do so. To facilitate such, I will make a copy of the CD which contains voluminous files and drop it by your office.

With the above said, I want to make clear that I am not in any way inferring that you have intentionally done anything wrong. I only believe that you may have been overly cautious in your assertion of the attorney client privilege. I request that you please provide me answers to my questions sometime within the next seven business days via email.



Santos told me of O'Banion's contact and asked me to draft a FAX (page 33) as suggested by his attorney to O'Banion asking point blank if the meeting was about Santos' Merced County Claim or his Grand Jury Complaint.

O'Banion's response (page 34) seems on the surface to be very innocent



and forthright. He disclaims any knowledge of the Grand Jury complaint and says he didn't believe it would be appropriate for him to talk about the pending Merced County Claim.

Let the Badger pose a few Columbo like questions whose reasonable answers I think will show it was not an innocent letter, but a, "Oh My God, Santos Told Forte" CYA (Cover Your A__) Letter.



1. When O'Banion got the fax from Santos, do you think he spoke about it or gave a copy of it to Fincher prior to responding to Santos two days later?

If O'Banion did then Fincher would have known about the Grand Jury Complaint if he didn't know about it before and knew no meeting should take place. So why did they still push for it?

2. Do you think O'Banion would have drafted a letter in response to Santos letter without having input from Fincher who he was arranging the meeting with and for?



3. Since O'Banion said he knew it would be inappropriate to speak about either the Grand Jury Complaint or the

pending Merced County Claim against Palsgaard (who would be represented by Fincher), why was he still going to arrange a meeting between Palsgaard/ Fincher evidenced in his response letter by saying "I look forward to setting a date and having a meeting"?



O'Banion knew that Fincher was the advisor to the Grand Jury and also the Risk Management Department that was handling the pending claim. Any meeting

taking place between them would be inappropriate.

An eight page letter with 13 accompanying exhibits from myself to Grand Jury Advisor Judge Hugh Flanagan described O'Banion's and Fincher's letter as "transparent track covering," and I requested an investigation of the matter.

In classic double speak, Judge Flanagan responded by babbling to the left and then babbling to the right saying that he was somehow sending something over to the Grand Jury for further action.

More than likely, he had Fincher draft the letter for him.

SHOCKING ARROGANCE



On March 4th, 2008, I received the Notice of Action rejecting the claim signed by Smith, the individual who the claim was FILED against. (See page 31). Smith, O'Banion, and Fincher rejected the claim filed against themselves.

MAKE MY DAY!

So, what would happen now if I were to file a another claim against Smith, O'Banion and Fincher for rendering a

decision on their own claim?

Well, it would make my day easier in demonstrating to citizens that no matter how outlandish a civil



servants action's are, there is no process in place for citizens to hold them accountable.

Now it doesn't matter if Fincher, O'Banion, and Smith did anything wrong concerning the alleged tampering with the Grand Jury complaint and previous claims by Santos and myself that Smith now rejected.

Does it seem that a reasonable citizen would doubt the objectivity of Smith, Fincher, and O'Banion in deciding the claim if the claim was made against themselves?

PUBLIC SCRUTINY

If you read, as suggested, "The Man from Badger Flats" prior to this article, you would better understand why it seems I am willing to bang my head against a concrete



wall. It is so that the public can scrutinize the actions of our civil servants.

Civil servant malfeasance and putting each other above the law cannot survive under public scrutiny.

My strategy is to bring as much public scrutiny upon what O'Banion, Fincher, and Smith did as I can. The reason being is that I think O'Banion may be one of the better civil servants of Merced County with a conscience left.

O'Banion does not need the money, and I personally do not think he would steal a dime from anyone. What I believe is more important to O'Banion is his name. I think that he may be remorseful about what he did at this time. He is also considerably concerned that it was I that caught him.

O'Banion made a couple serious mistakes out of the box. One was trying to tip the scales as a favor to other civil servants, Fincher, DA Larry Morse, and officials of MCDEH. O'Banion should have let the chips fall where they may for Merced County civil servants that messed with Santos and were caught by me doing so.

Next, O'Banion miscalculated that his long term friendship with Santos would be able to sway Santos from following my suggestions in dealing with uncivil civil servants, and he would be able to get Santos to pull me off of them.



What O'Banion forgot was that when Assistant DA Matt Maclear accused me of "making up the story of his threatening Santos with criminal prosecution for my own personal gain," it was a personal and slanderous attack upon me. It is something that I will not let die, and Santos knows that he has no control over my bringing these guys to their knees for saying it.

Personally, I think that O'Banion in his early years sincerely wanted to help citizens. In later years, he has lost sight of who he owes allegiance to and will not hold other civil servants accountable whom he has run with for many years.


